The **Digital Envision LLC - enMedallo Platform**, offers an application that allows **Users** to publish, offer, search and book services. Members who publish and offer their services are **Organizers**, while members who search, book or use services are **Users**. The **Organizers** offer events in the city of Medellin, activities, excursions and all kinds of social events. You must

register an account to access and use many features of the **Digital Envision LLC - enMedallo Platform**, as well as ensure that the account information is accurate. As a provider of the **Digital Envision LLC - enMedallo Platform**, **Digital Envision LLC - enMedallo Platform** does not own, control, offer or manage any advertisements or services of the **Organizers**. **Digital Envision LLC - enMedallo Platform LLC** is not a party to contracts entered into directly between **Organizers** and **Users**, nor is it an agent for events. **Digital Envision LLC - enMedallo Platform** does not act as an agent for any member.

2. DEFINITIONS:

- a. **Organizers:** Natural or legal person that exhibits, offers and markets products and/or services through the **Digital Envision LLC - enMedallo Platform**, so that they may be acquired by the **Users**.
- b. **Ambassadors:** Natural or legal person in charge of promoting the platform.
- c. **Users:** Natural person who, as the final recipient, uses the **Digital Envision LLC - enMedallo Platform** to acquire the products and/or services exhibited, offered and marketed by the **Organizers**, through the platform.
- d. **Personal Data:** Any information that makes it possible to identify or make a natural person identifiable.
- e. **Digital Envision LLC - enMedallo Platform:** Virtual Platform composed of an application for mobile devices through which the **Organizers** exhibit, offer and commercialize products and/or services to be acquired by the **Users**.

- 3. OBJECT: The present terms and conditions regulate the authorization of use granted by the **Digital Envision LLC - enMedallo platform** to the **Users** so they can use of the Platform, which connects the **Organizers**, with the **Users**, so that the latter can be informed about the products and services offered and marketed by the **Organizers**, and can acquire the same through the **Digital Envision LLC - enMedallo Platform**.

4. **ACCEPTANCE OF THE TERMS AND CONDITIONS:** The user, at the time of registering on the **Digital Envision LLC - enMedallo Platform**, voluntarily accepts in a prior, express and informed manner the content of these terms and conditions in its entirety, for which he/she is irrevocably bound to.

The natural person who accepts these Terms and Conditions declares and guarantees to be the user who will make use of the **Digital Envision LLC - enMedallo Platform**.

5. **FUNCTIONING OF THE DIGITAL ENVISION LLC - enMedallo PLATFORM:** **Digital Envision LLC - enMedallo Platform** is a virtual platform, through which the following can be connected: (i) **Organizers** and (ii) **Users**. Thus, through the **Digital Envision LLC - enMedallo Platform**, the **Organizers** can exhibit their products and/or services, so that they can be acquired by the **Users**.

It is important to clarify that **Digital Envision LLC - enMedallo Platform** does not provide event logistics services to **Users**. The prices, quantity, availability and characteristics of the products and/or services displayed on the **Digital Envision LLC - enMedallo Platform** are determined directly by the **Organizers** and not by **Digital Envision LLC - enMedallo Platform**.

Taking into account, and pursuant to Article 53 of Law 1480 of 2011 and the Guide for Consumer Protection of Electronic Commerce, issued by the Superintendence of Industry and Commerce, **Digital Envision LLC - enMedallo Platform** is a contact portal.

6. **DUTIES OF THE USER:** By virtue of the acceptance of these terms and conditions the user undertakes to:
- A. Enter your personal data truthfully at the time of registering on the **Digital Envision LLC - enMedallo Platform**.
 - B. Refrain from transferring your login information to other people.
 - C. Notify **Digital Envision LLC - enMedallo Platform** regarding any unauthorized use of your account within the **Digital Envision LLC - enMedallo Platform**.

- D. Refrain from using the **Digital Envision LLC - enMedallo Platform** to perform acts contrary to morality, law, public order and good customs against **Digital Envision LLC - enMedallo Platform**, ambassadors or **Organizers**.

- M. Paragraph one: The legal representatives of **Users** who are minors expressly declare that they have authorized the latter to register on the **Digital Envision LLC - enMedallo Platform**, with the understanding that they are responsible for the use of the Platform by underage **Users**.

Paragraph two: Any purchase made through the **Digital Envision LLC - enMedallo Platform**, shall be subject to the general terms and conditions established by the organizer.

In the event of non-compliance with any of the obligations contained in this section, **Digital Envision LLC - enMedallo Platform** reserves the right to permanently block the user's account on the **Digital Envision LLC - enMedallo Platform**.

7. DUTIES OF DIGITAL ENVISION LLC - enMedallo PLATFORM: Under these Terms and Conditions **Digital Envision LLC - enMedallo Platform**, agrees to:

- A.** Inform in a clear, updated and sufficient manner on the **Digital Envision LLC - enMedallo Platform** the contact and identification data of **Digital Envision LLC - enMedallo Platform**.
- B.** Establish a visible and easily identifiable link on the **Digital Envision LLC - enMedallo Platform** that allows the user to access the page of the Superintendence of Industry and Commerce.
- C.** Inform **Users** about the payment methods enabled within the platform.
- D.** Indicate to the user the data of the Organizer ally, who, freely and voluntarily, has accepted the management of the mandate requested by the user through the **Digital Envision LLC - enMedallo Platform**.
- E.** Make available to **Users** and/or **Organizers** the terms and conditions of use of the **Digital Envision LLC - enMedallo Platform** in an updated form.

Paragraph one: **Users** acknowledge and accept that **Digital Envision LLC - enMedallo Platform**, is an information platform.

Paragraph two: **Digital Envision LLC - enMedallo Platform**, is not responsible for schedule, security conditions, locations, realization, organization or content of the event, this responsibility is of the organizer, which appears with name and identification in the publicity.

- 8. DUTIES OF Organizers:** The organizer, being the one who exhibits, offers and markets the products and/or services through the **Digital Envision LLC - enMedallo Platform**, shall:
- A.** Deliver to **Digital Envision LLC - enMedallo Platform** truthful, timely, official, updated information regarding the events that will be published on the **Digital Envision LLC - enMedallo Platform**.
 - B.** Fully comply with the rules regarding advertising, commercial promotion that are applicable to their products and/or services.
 - C.** Have permits and licenses from the competent authorities to display, offer and market products and / or services through the **Digital Envision LLC - enMedallo Platform**.
 - D.** Comply with all those rules relating to the marketing of products and services, including without limitation Law 1480 of 2011.
 - E.** Respond to any user who has made use of the **Digital Envision LLC - enMedallo Platform** for the purchase of tickets to attend an event and that the event does not take place.
 - F.** Acknowledge that the **Digital Envision LLC - enMedallo Platform** will only be a means for the acquisition of potential customers, but will not be a partner that will be responsible for the development of the activities.
 - G.** To provide **Users** with all the information for the development of the products and/or services promoted on the **Digital Envision LLC - enMedallo Platform**.
 - H.** Acknowledge and agree that they are independent and do not have a contractual relationship and/or provision of services with **Digital Envision LLC - enMedallo Platform**, therefore **Digital Envision LLC - enMedallo Platform** is not responsible for their actions or omissions.
 - I.** Provide the **Digital Envision LLC - enMedallo Platform** with all company data, Chamber of Commerce or citizenship card, depending on the specific case.
 - J.** Establish prices equal to those established in any other advertising media.
 - K.** Allow the use of photographs of the product and/or service in order to advertise the same.
 - L.** Refrain from using the **Digital Envision LLC - enMedallo Platform** to perform acts contrary to morality, law, public order and decency against **Digital Envision LLC - enMedallo Platform**, ambassadors or **Users**.

9. **HELP CENTER:** The user has the following email: hola@enmedallo.com, to submit Petitions, complaints, claims and suggestions, regarding the products and/or services requested through the **Digital Envision LLC - enMedallo Platform**. It is clarified that the Petitions, complaints, claims and suggestions will be processed in accordance with the terms established by **Digital Envision LLC - enMedallo Platform**, which will be informed to **Users**.

The user acknowledges and accepts that the processing of the Petitions, complaints, claims and suggestions by **Digital Envision LLC - enMedallo Platform** does not imply that it is the producer and/or supplier of the products and/or services exhibited, offered and marketed by the **Organizers** through the **Digital Envision LLC - enMedallo Platform**.

This procedure represents an added value that **Digital Envision LLC - enMedallo Platform** makes available to the user, in order to improve their experience on the **Digital Envision LLC - enMedallo Platform**.

10. MISUSE OF THE DIGITAL ENVISION LLC - enMedallo PLATFORM:

Without prejudice to other measures, **Digital Envision LLC - enMedallo Platform** may temporarily or permanently block the account of the user or the organizer in the **Digital Envision LLC - enMedallo Platform**, in the case in which any of the following events are verified:

- a) Failure to comply with Colombian Law.
- b) Failure to comply with any of the provisions of these terms and conditions.
- c) If the user or organizer, incurs in conduct detrimental to **Digital Envision LLC - enMedallo Platform** and/or third parties.
- d) If the identity could not be confirmed or any information provided by the user or the organizer is erroneous.

Paragraph one: In the event of any of the situations described in this section, **Digital Envision LLC - enMedallo Platform** undertakes to cooperate with the corresponding authorities, and, upon a court order, reserves the right to perform a forensic analysis on the devices of the user and organizer.

11. **INDEMNITY:** The organizer, undertakes to defend and hold harmless **Digital Envision LLC - enMedallo Platform** for any event resulting from the unauthorized use of the **Digital Envision LLC - enMedallo Platform** by

these or the breach of any development of the provision of the service and / or product, or any breach of these terms and conditions.

12. METHOD OF PAYMENT: The payment of the orders requested through the **Digital Envision LLC - enMedallo Platform** will be made through the payment method registered and selected by the user on the platform.

Likewise, the user declares and acknowledges that:

Notices once received by **Digital Envision LLC - enMedallo Platform** are subject to subsequent approval. The company may request modification of the content of the posting if it is deemed unsuitable.

14. RIGHT OF WITHDRAWAL: In the event that the user wishes to exercise the right of withdrawal with respect to a product and / or service purchased through the **Digital Envision LLC - enMedallo Platform**, the user must approach directly to the establishment of trade of the respective Organizer, in cases where it is appropriate and enforceable as provided in Article 47 of Law 1480 of 2011.

15. SENDING OF COMMUNICATIONS LAW 2300 OF 2023: By accepting these terms and conditions you grant your express, free and voluntary authorization for **Digital Envision LLC - enMedallo Platform**, to contact you for the purpose of sending you notifications for advertising and promotional purposes. Notifications may be sent at the following times as established in the standard: Monday through Friday between 7:00am to 7:00pm, Saturdays from 8:00am to 3:00 pm and Sundays and holidays will be contacted at any time.

We remind you that inside the **Digital Envision LLC - enMedallo Platform** you will be able to customize the way you prefer to receive these notifications.

16. PRICES DISPLAYED ON THE DIGITAL ENVISION LLC - enMedallo PLATFORM: The prices of the products and/or services displayed on the **Digital Envision LLC - enMedallo Platform** are set by the **Organizers**, who act as suppliers and/or producers thereof.

17. INTELLECTUAL PROPERTY: All content included on the Platform that alludes to **Digital Envision LLC - enMedallo Platform** such as text, artwork, logos, button icons, source codes, images, audio clips, digital

downloads, data compilations, and in general the "look and feel" of the site are the property of **Digital Envision LLC - enMedallo Platform**, and are protected by applicable laws and international conventions on intellectual property.

Such trademarks, trade dress, may not be used without express authorization, in connection with any product or service that is likely to cause confusion among **Users** and in any manner that disparages or discredits **Digital Envision LLC - enMedallo Platform**.

18. 19. 21. PROHIBITION OF CHILD LABOR: **Digital Envision LLC - enMedallo Platform** recognizes and protects the basic rights of children in accordance

with the precepts set forth in Principle 5 of the Global Compact, the Convention on the Rights of the Child, the United Nations International Bill of Human Rights and the standards established by the International Labor Organization (ILO) on child labor.

22. POLICY OF COMMITMENT TO PREVENT AND COUNTERACT THE SEXUAL TOURISM OF MINORS: Digital Envision LLC - enMedallo Platform, is committed to promote Law 679 of 2001, whose objective is the establishment of rules to prevent and counteract exploitation, pornography and sex tourism with minors to and from Colombia, in development of Article 44 of the Political Constitution of Colombia.

In this sense, it is our duty to inform all our **Users** and **Organizers** of article 17 of Law 679 of 2001: *"Sexual exploitation and abuse of minors are criminally and administratively sanctioned in Colombia"*.

23. MODIFICATIONS: Digital Envision LLC - enMedallo Platform may modify autonomously and at any time formal, procedural or substantial aspects of these terms and conditions of use of the **Digital Envision LLC - enMedallo Platform**, which will be updated and made available to **Users**.

CHAPTER II - TERMS AND CONDITIONS Organizers:

1. BEING AN ORGANIZER ON DIGITAL ENVISION LLC - enMedallo PLATFORM.

- a. **Organizer:** As an Organizer, **Digital Envision LLC - enMedallo Platform**, offers you the right to use the Platform to share your events, activities, excursions and all kinds of social events, with our community of **Users** and thus generate greater reach, traffic, community and sales through a different channel. Publishing an event is easy and you are in control of your service: how you set your price, the availability and the rules of each Ad.
- b. **Contracting with Users:** When the Organizer receives a reservation request through **Digital Envision LLC - enMedallo Platform**, is entering into a contract directly with the User and likewise will be responsible for delivering its service on the terms and conditions specified in your ad and / or information provided to the user. Notwithstanding the foregoing, any terms, policies or conditions included in any supplemental contract with **Users** must be consistent

with these terms and conditions, with the privacy policy and information provided in your ad.

- c. **Organizer Independence:** The Organizer's relationship with **Digital Envision LLC - enMedallo Platform** is that of an independent person or entity and not that of an employee, agent, joint venture or partner of **Digital Envision LLC - enMedallo Platform**.

Digital Envision LLC - enMedallo Platform does not direct or control the Organizer's service and you agree that it has full discretion as to how and when to provide the services and at what price and on what terms to offer them.

2. ADMINISTRATION OF THE ADVERTISEMENTS:

- a. **Ads Creation: Digital Envision LLC - Platform enMedallo** makes the Platform available to **Organizers** to set up, manage and advertise their event. Your Advertisement must include complete and accurate information about the event, activity, excursion or social event, its price, applicable charges and any applicable rules or requirements for its **Users**. You are responsible for keeping the information and content of your Event current and accurate at all times.
- b. **Compliance with legal obligations:** You are responsible for understanding and complying with all laws, rules, regulations and contracts with third parties that apply to your Events. For example: The realization of some events requires compliance with requirements by Colombian authorities (Public Space), the contracting of policies, among others. Therefore, we suggest you consult local regulations to know which ones apply to the realization of the event you plan to offer, since in any case, **Digital Envision LLC - enMedallo Platform** will not be responsible for the failure to conduct an event for failure to comply with legal requirements and / or any other cause resulting from unauthorized use of **Digital Envision LLC - enMedallo Platform** by these or the breach of any development of the provision of the service and / or product, or any breach of these terms and conditions.

You shall independently substantiate your obligations, additionally, as Organizer you shall be responsible for managing and using the personal data of **Users** and others in accordance with applicable privacy laws and these T&Cs, including our privacy policy. If you are in any doubt as to how local laws apply, you should seek legal advice at all times.

- c. **Posting Rules:** By using **Digital Envision LLC - enMedallo Platform**, you are participating in a community that is intended for all of our **Users**. Therefore, we reserve the right to remove any content posted on the website or other channels at

any time and for any reason without notice. - Discriminates on the basis of race, religion, national origin, gender, age, marital status, sexual orientation or disability, or refers to such matters in any manner prohibited by law.
- Violate any municipal or state law, rule, regulation or ordinance, or attempt to encourage such evasion or violation.
- Unfairly interfere with any other party's uninterrupted use and enjoyment of the Platform or other channels.
- Upload copyrighted or other proprietary material of any kind to the Website without the express permission of the owner of that material.
- Use or attempt to use another person's account, password, service or system, except as expressly permitted by these Terms and Conditions.
- Include images, photos, articles or other content that constitutes, promotes or encourages illegal acts, violation of any rights of any individual or entity, violation of any local, state, national or international law, rule, guideline or regulation, or otherwise creates liability.
- Upload or transmit viruses or other harmful, disruptive or destructive files.
- Disrupt, interfere with or otherwise damage or violate the security of the website, or any services, system resources, accounts, passwords, servers or networks connected to or accessible through the website, other channels or affiliated or linked sites.
- Collect or store personal data of other **Users**.

A violation of any of the posting rules may be referred to the appropriate authorities.

- d. **Liability for Advertisements:** The Organizer is responsible for its own acts and omissions and is also responsible for the acts and omissions of any person it permits to participate in the provision of its services. Likewise, it shall be responsible for establishing the price, rules and requirements of its Advertisement and shall describe the charges, conditions in the description of its Advertisement and may not charge any additional fees or charges outside of **Digital Envision LLC - enMedallo Platform**, except those expressly authorized or informed.

3. DURATION, TERMINATION, SUSPENSION AND OTHER MEASURES:

- a. **Term of Agreement:** The agreement between you and **Digital Envision LLC - enMedallo Platform**, commences effective when you access **Digital Envision LLC - enMedallo Platform**, create an account and agree to these terms and conditions and will remain in effect until terminated by you or **Digital Envision LLC - enMedallo Platform** pursuant to the following terms.
